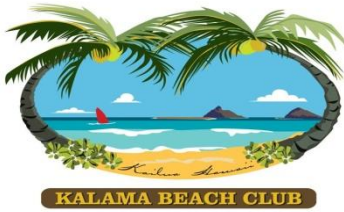

II. Membership Definitions and Policies – Please read

Membership in Kalama Beach Club is comprised of two broad categories:

- III. Members who own property in Kalama Tract (Tract Members), and
- IV. Members who do not own property in Kalama Tract.

Active members are those whose dues are current. Memberships are not transferrable unless a Tract Member sells their real property and the Tract Member is current in the payment of annual dues.

Members of the Kalama Beach Club who own property in the “Kalama Tract” as defined in the Kalama Beach Club Deed of Trust dated February 14, 1928 (see map <http://kalamabeachclub.com/about/membership/>) are issued a certificate designating their Shares in the property. Active Members are entitled to:

- i. full voting rights
- ii. receipt of a monetary distribution in the event the Kalama Beach Club is sold
- iii. use of Kalama Beach Club as outlined below
- iv. keys to the Kalama Beach Club (current cost of first key \$25, replacement keys \$35 each)
- v. receipt of a periodic electronic newsletter
- vi. rental space for kayak/surfboards/canoe (as space becomes available)
- vii. discounts, if available, for events sponsored by Kalama Beach Club

Members of the Kalama Beach Club who do not own property in the “Kalama Tract” as defined in the Kalama Beach Club Deed of Trust dated February 14, 1928 (see map <http://kalamabeachclub.com/about/membership/>) are not shareholders of the property or certificate holders of the Club and thus do not have voting or distribution rights. This Membership category is a REVOCABLE LICENSE¹ and may be revoked by majority vote of the Executive Committee of the Kalama Beach Club. These active members are entitled to:

- i. use of Kalama Beach Club as outlined below
- ii. keys to the Kalama Beach Club (current cost of first key \$25, replacement keys \$35 each)
- iii. receipt of a periodic electronic newsletter
- iv. rental space for kayak/surfboards/canoe (as space becomes available)
- v. discounts, if available, for events sponsored by Kalama Beach Club

All members must agree to abide by the rules and policies adopted by the Executive Committee of the Kalama Beach Club now in effect, or which may be hereafter adopted, including changes and adjustments in annual member assessment.

All members release Kalama Beach Club of all liability while using the Club facilities. **A member must be present at the Club at all times the member’s children, dependents, or non-member guests are on the premises. Members will be held responsible for their children, dependents and guests using the facility.**

All active Members in good standing have unreserved, free use of the Club on ‘green flag’ days (when the Club is not reserved) from 9 a.m. to 9 p.m. Members are welcomed to bring guests to the Club for unreserved events. Club capacity is 150. **Members must follow all Clubhouse Rules posted on the website and at the Club.**

Active Members paying the \$1000 Administrative Fee may have a one day private rental of the Club for up to 150 guests at a discounted rate (prices subject to change by club management). The regulations for private rental are on the Kalama Beach Club website (<http://kalamabeachclub.com/about/club-rules/>). ¹ Any dues paid for the year of revocation will be refunded on a pro rata basis.

To maintain active membership annual dues must be paid within three months of due date to avoid a late fee of \$50 or, if overdue for more than 180 days a late fee of \$100. Annual dues may be paid by cash, check or through electronic transfer. Annual dues for members who live in the Kalama Tract as defined by the Kalama Beach Club Deed of Trust are \$300 + Tax = \$314.13. Annual dues for members who do not live in Kalama Tract are \$480 + Tax = \$502.62. For new members, dues will be prorated.

III. Membership Administrative Fees

A one time administrative fee must accompany this application. Please submit a check made payable to Kalama Beach Club with your application and mail to: Kalama Beach Club, PO Box 877, Kailua, Hawaii 96734. Please note that administrative fees are subject to change.

All applications will be reviewed by the Kalama Beach Club Executive Committee and notification of acceptance of membership will be made by the Executive Committee. If any application for membership is not accepted, the administration fee will be refunded.

IV. Current Year Dues

Upon acceptance as a Member, you will be sent an invoice for the dues owed and the cost of the club key plus all applicable taxes. Current year dues will be pro-rated by month depending on your chosen membership start date. Annual dues for members who live in the Kalama Tract as defined by the Kalama Beach Club Deed of Trust are \$300 + Tax = \$314.13. Annual dues for members who do not live in Kalama Tract are \$480 + Tax = \$502.62.

Once the current year dues and key fee are paid, your key to the Kalama Beach Club will be available for pick up.
